Group Tuition is based on 45 minute, weekly lessons for each student at \$15 per lesson plus a \$5 registration fee for 5 or more students in each group; if less than 5 students register, lessons will be held but tuition will be pro-rated. ### Program Policies

#### **Payment Policy**

Full tuition must be paid even if a student discontinues lessons. The **non-refundable** tuition is to be paid in full at registration or in installments as detailed on the Registration Form. Accounts payable on the payment plan must be up to date for the lessons to be continued.

#### **Absence Policy**

There are no make-ups for student absences and such cancellations will not result in any type of adjustment of tuition. At the beginning of the semester, specific days and times for lessons are agreed upon between parents/guardians, students and instructors through the Academy office. If an instructor is absent, every effort will be made to make up lessons.

#### **Publicity Permission**

The Academy for the Performing Arts has my permission to take photographs of my child(ren) to be used in various promotional and publicity displays, news articles, grant funding applications, and the company website as indicated by my signature on registration form.

#### **Other Policies**

- Children are to be escorted to the music studio at the beginning of lesson and met at the classroom door at the conclusion of each lesson.
- The Academy is not responsible for musical instruments or any personal belongings left on the premises.
- Students must provide an instrument for the lesson with the exception of piano, however, if taking piano lessons, student must have an instrument at home to practice.
- The Academy will place a message on the telephone answering system regarding cancellations /resuming lessons in the event of inclement weather.
